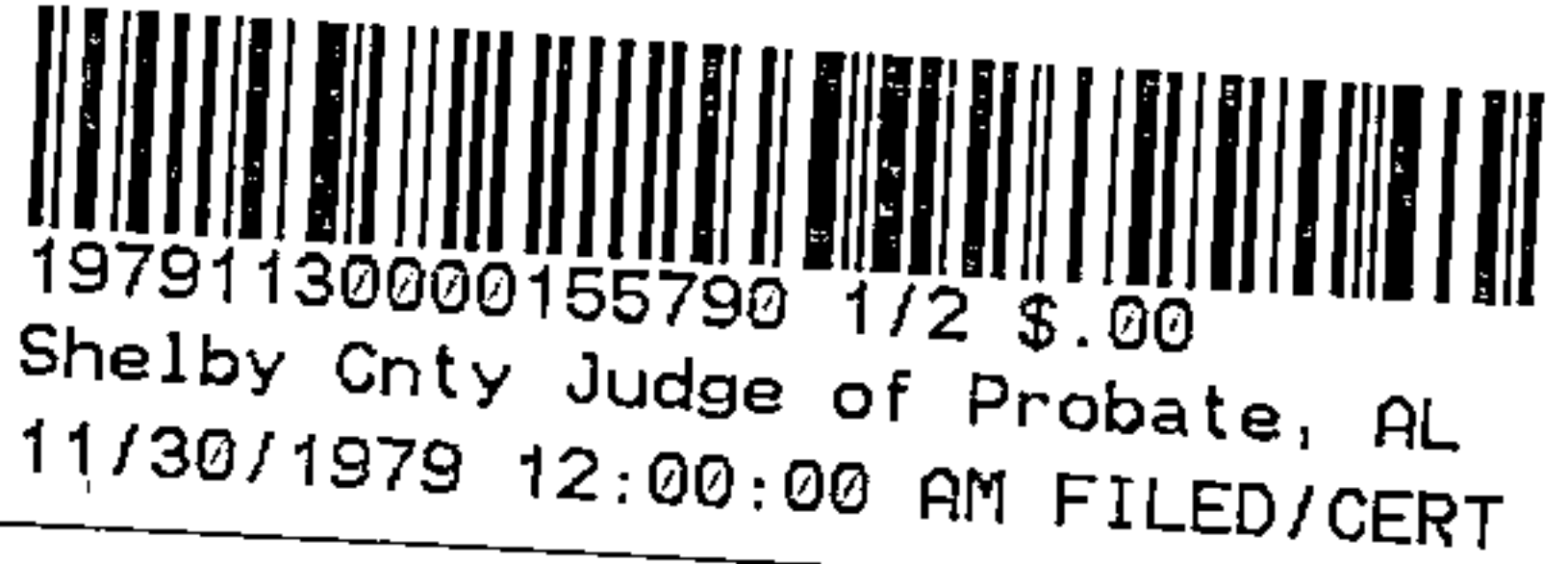

things whatsoever requisite and necessary to be done in and about the premises, as fully to all  
intents and purposes, as I might or could do if personally present. I hereby revoke all powers of  
attorney by me theretofore made authorizing any person to do any act relative to said above-mentioned  
and described lands, or any part thereof, hereby ratifying and confirming whatsoever the herein  
appointed attorney, or any of his substitutes appointed by him, may do in the premises by virtue  
hereof. The rights, powers and authority of said attorney in fact to exercise any and all of the rights  
and powers herein granted shall commence and be in full force and effect on November 21 1979  
and such rights, powers, and authority shall remain in full force and effect thereafter until revoked  
in writing by me, even though I may become totally disabled.
