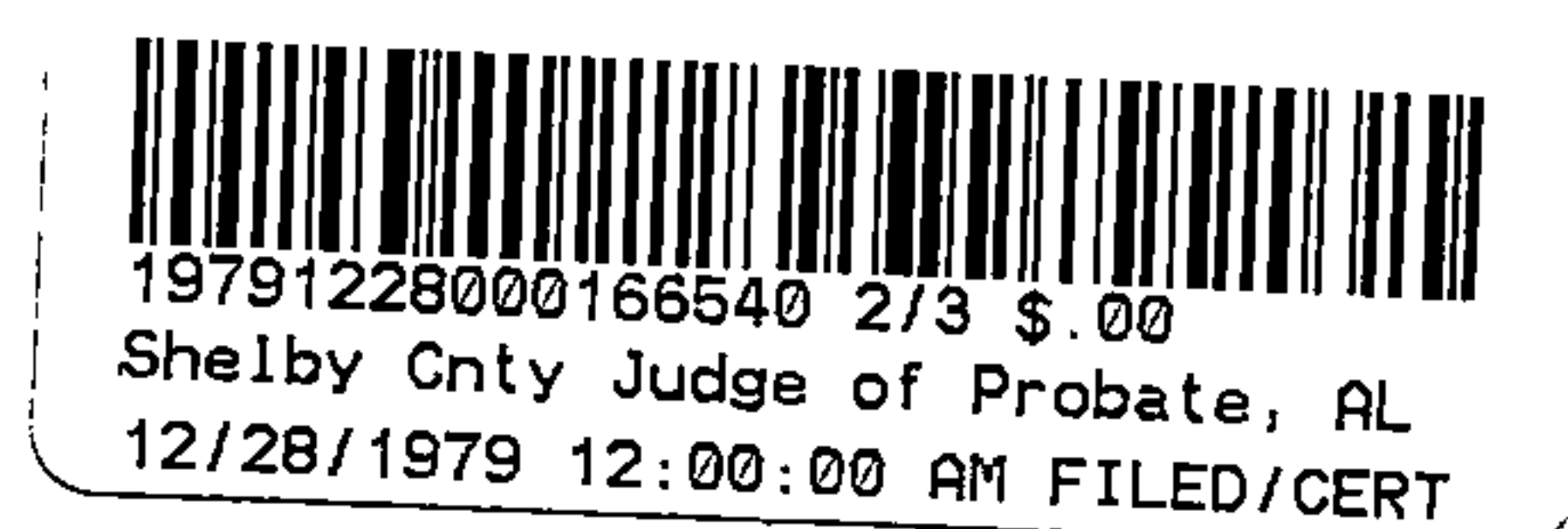
KNOW ALL MEN BY THESE PRESENTS, that I, Lurene H. Lawrence, of Childersburg, Talladega County, Alabama, have made, constituted and appointed, and by these presents do make, constitute and appoint, my husband, Millard W. Lawrence, and my daughter, Betty L. Jones, or either of them, as my true and lawful attorneys, for me and in my name, place and stead to do, execute, and perform all and every act, or acts, thing or things, in law needful, necessary, or convenient to be done, as fully, largely, and amply, to all intents and purposes whatsoever as I might or could do if acting personally. And especially, but not in limitation of the foregoing powers, to ask, demand, sue for, recover and receive of and from all persons, corporations, associations, and other entities whomsoever, all and every sum or sums of money, or other property, real, mixed or personal, due and owing, or that may become due and owing to me or which I may be entitled to receive on any and every account, whether I am now entitled or may hereafter become entitled thereto, whether due or to become due, and to give receipts for same, or at the discretion of my said attorneys to compound or compromise for same, and give discharges and releases, all as I might or could do; to sign, draw, make, endorse, execute and deliver instruments, notes, checks, bills, deeds, bonds, obligations, contracts or other papers; to sell, lease or otherwise convey all, or any part or parts, of said real, mixed or personal estate, or any interest which I may now have, or may hereafter acquire in any real, mixed, or personal estate wheresoever situate, to make all

necessary deeds and conveyances thereof, with all necessary covenants and warranties and assurances, and to sign, seal, acknowledge and deliver the same; to make investments of my property in the discretion of my said attorneys and without being restricted to so-called legal investments; to establish an agency account for the management and investment of any part or all of my property, in any banking or investment institution or business; to hire agents, attorneys, or other employees and to compensate them for services rendered for me or in the management of any of my property; to prepare, execute, and file income and other tax returns of any nature required by any Government, and to act for me and to represent me before the Treasury Department of the United States, or any division thereof, any and all courts or agencies of the United States Government, and any and all courts departments, agencies, and divisions of any other Government and to deal with the representatives thereof in connection with any of my tax matters; to expend either income or principal or both for my support, maintenance, and comfort; and to do all such other acts, matters, and things in relations to all and any part, or parts, of or interest in my property, estate, affairs, or business of any kind or description in the State of Alabama, or elsewhere, as fully as I myself, might or could do if acting personally. And I hereby ratify and confirm all lawful acts done by my said attorneys, by virtue hereof.

It is specifically intended by this power of attorney to allow my said attorneys to act individually or collectively when performing any of the above mentioned lawful acts in my behalf and that the signature of only one of my two co-attorneys shall be required
