

WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

That in consideration of One Dollar (\$1.00) and other good and valuable consideration, to the undersigned grantors, in hand paid by the grantee herein, the receipt whereof is acknowledged, we, Bert N. Adams, William W. Adams, Jr. and Commercial Bank of Liberty, N.A., trustees under Trust Agreement dated August 19, 1977, of which William W. Adams, Sr. was grantor, of Clay County, Missouri (herein referred to as Grantors), do grant, bargain, sell and convey unto

Bert N. Adams of Madison, Dane County, Wisconsin (herein referred to as Grantee),

the following described real estate, situated in Shelby County, Alabama, to-wit:

A seven thirty-seconds (7/32) undivided interest in:

West 1/2 of Section 23, Township 19, Range 1 West; South 1/2 of the Southeast 1/4; Northwest 1/4 of the Southeast 1/4; North 1/2 of the Northeast 1/4, all in Section 23, Township 19, Range 1 West.
