

WARRAMTY DEED

That in consideration of One Dollar (\$1.00) and other good and valuable consideration, to the undersigned grantors, in hand paid by the grantee herein. the receipt whereof is acknowledged, we, William W. Adams and Diane Betts Adams, husband and wife, of Madison, Dane County, Wisconsin, (herein referred to as Grantors), do grant, bargain, sell and convey unto

William W. Adams, Jr., Trustee under Trust Agreement dated  $D_{c.c.}$  21.1979, with William W. Adams, Jr. as Grantor (herein referred to as Grantee),

the following described real estate, situated in Shelby County, Alabama, to-wit:

A one-half (1/2) undivided interest in:
