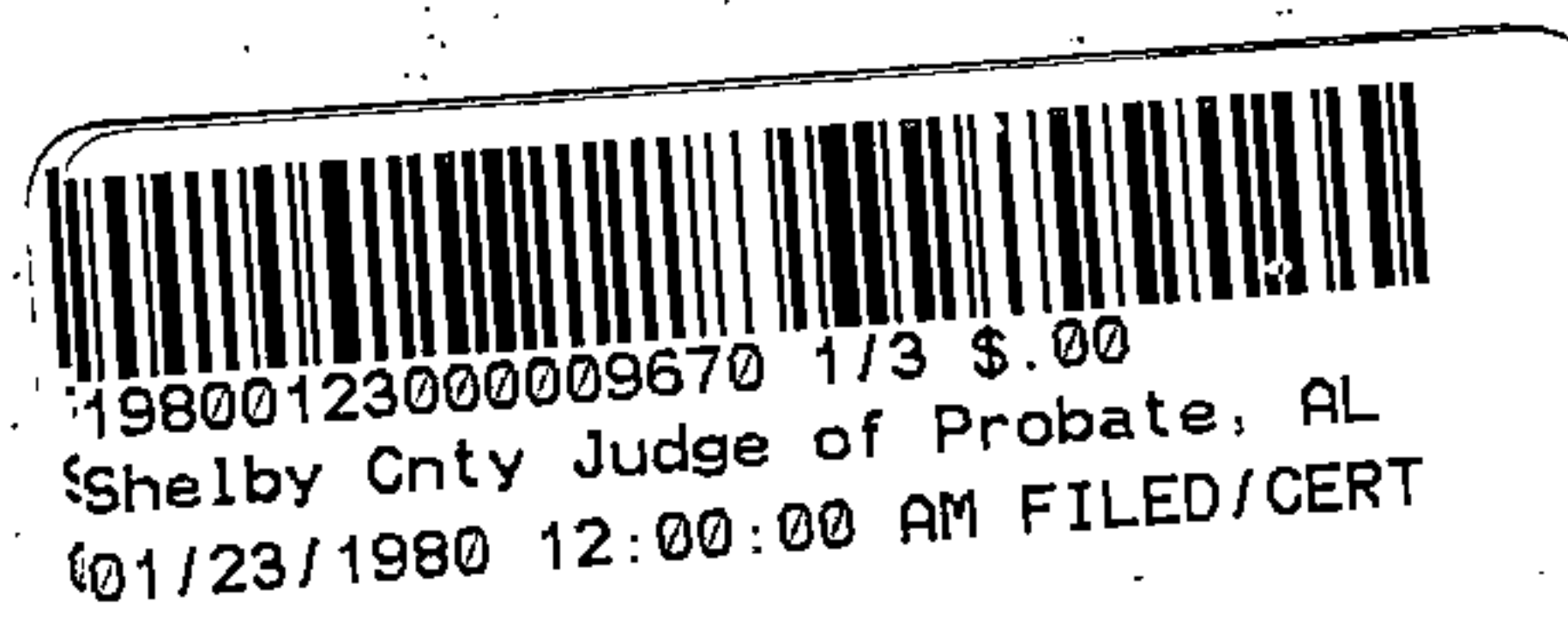

DECLARATION OF VACATION OF CERTAIN STREET

AS IT APPEARS ON MAP OF SUNRISE COVE

WHEREAS, we, the undersigned, T. W. Cadle and wife, Nellie Faye Cadle; Thurman E. Newman and wife, Millie B. Newman; separately and severally, are the owners of all property abutting the hereinafter described street, as same appears on the survey of Sunrise Cove, as recorded in Map Book 5, Page 31 in the Probate Office of Shelby County, Alabama, which map shows the location of the street herein described;

WHEREAS, we, T. W. Cadle and wife, Nellie Faye Cadle; Thurman E. Newman and wife, Millie B. Newman, are desirous of vacating said street, as same appears on said map and which street is described as follows:

All that part of Cove Drive lying South of the Northwesterly extension of the South line of Lot 14 of Sunrise Cove Subdivision as recorded in Map Book 5, Page 31 in the Probate Office of Shelby County, Alabama; said street being more particularly described as follows:
Commence at the Southwest corner of Lot 14 of Sunrise Cove Subdivision as recorded in Map Book 5, Page 31 in said Probate Office; thence run South along the East line of Cove Drive a distance of 310 feet, more or less, to the end of Cove Drive; thence turn an angle of 92 deg. 28 min. 30 sec. to the right and run a distance of 60 feet to a point on the West line of Cove Drive; thence turn an angle of 87 deg. 31 min. 30 sec. to the right and run along the West side of Cove Drive a distance of 318 feet, more or less, to the point of intersection with the extension of the South line of Lot 14 of said subdivision; thence turn an angle of 99 deg. 20 min. to the right and run a distance of 60 feet, more or less, to the point of beginning.

WHEREAS, said street never has been nor is it now being used as a public road or street;

NOW, THEREFORE, we, the undersigned, T. W. Cadle and wife, Nellie Faye Cadle; Thurman E. Newman and wife, Millie B. Newman, do hereby declare that portion of said map described herein to be

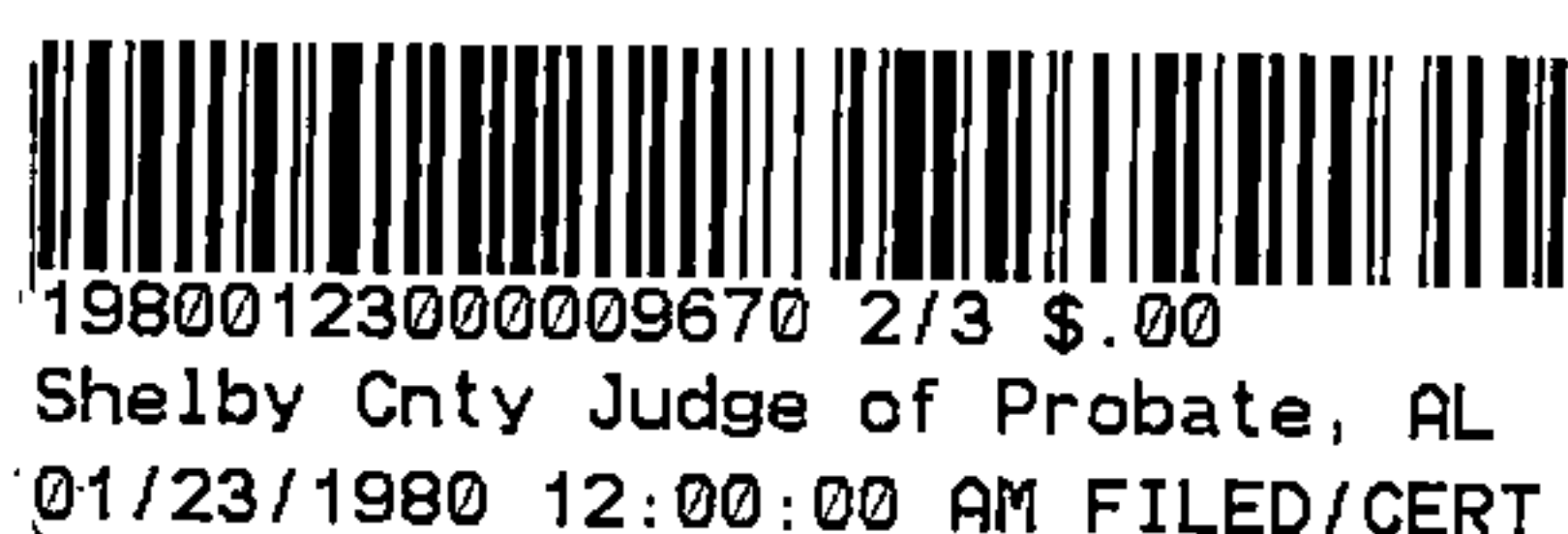
vacated as shown by the map of said subdivision; and the following street shown thereon is hereby vacated:

All that part of Cove Drive lying South of the Northwesterly extension of the South line of Lot 14 of Sunrise Cove Subdivision as recorded in Map Book 5, Page 31 in the Probate Office of Shelby County, Alabama; said street being more particularly described as follows:
Commence at the Southwest corner of Lot 14 of Sunrise Cove Subdivision as recorded in Map Book 5, Page 31 in said Probate Office; thence run South along the East line of Cove Drive a distance of 310 feet, more or less, to the end of Cove Drive; thence turn an angle of 92 deg. 28 min. 30 sec. to the right and run a distance of 60 feet to a point on the West line of Cove Drive; thence turn an angle of 87 deg. 31 min. 30 sec. to the right and run along the West side of Cove Drive a distance of 318 feet, more or less, to the point of intersection with the extension of the South line of Lot 14 of said subdivision; thence turn an angle of 99 deg. 20 min. to the right and run a distance of 60 feet, more or less, to the point of beginning.

WE, the said T. W. Cadle and wife, Nellie Faye Cadle; Thurman E. Newman and wife, Millie B. Newman, do hereby pursuant to and in accordance with the provisions of Section 23-4-20, Code of Alabama 1975, join in the execution of this written declaration of vacation of said street, the same not being within the limits of any municipality.

Such vacation will not deprive other property owners of a convenient and reasonable means of ingress and egress to their property.
