

have been discharged, and hereby release and discharge the lien of the same, and the Judge of Probate of


Shelby, Alabama, as attorney-in-fact of the undersigned, is hereby authorized and directed

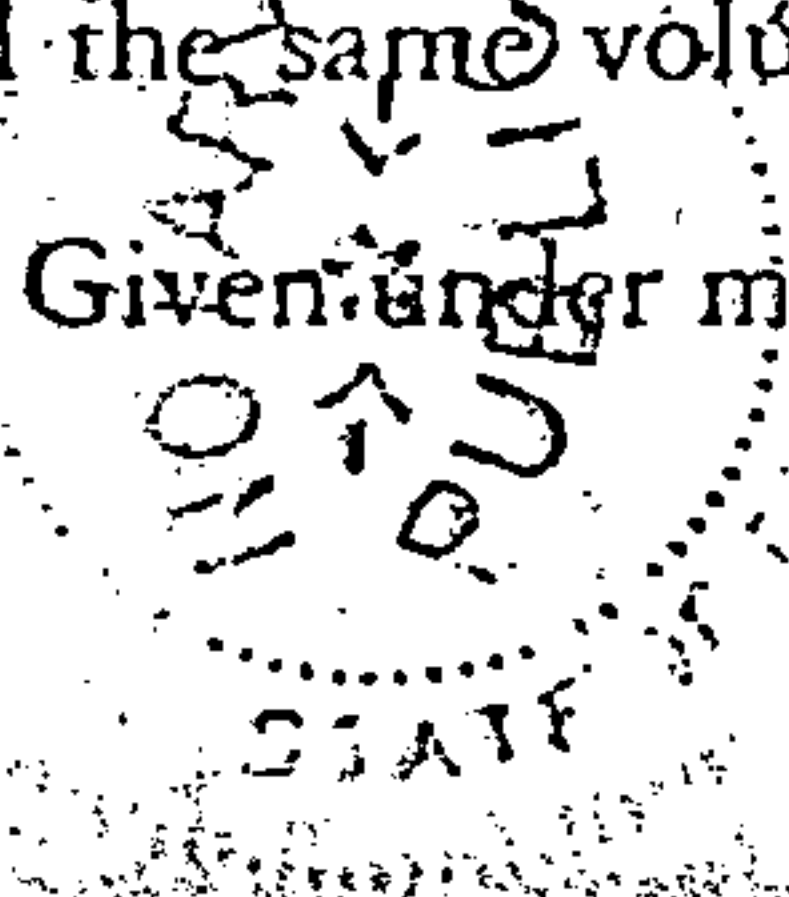


