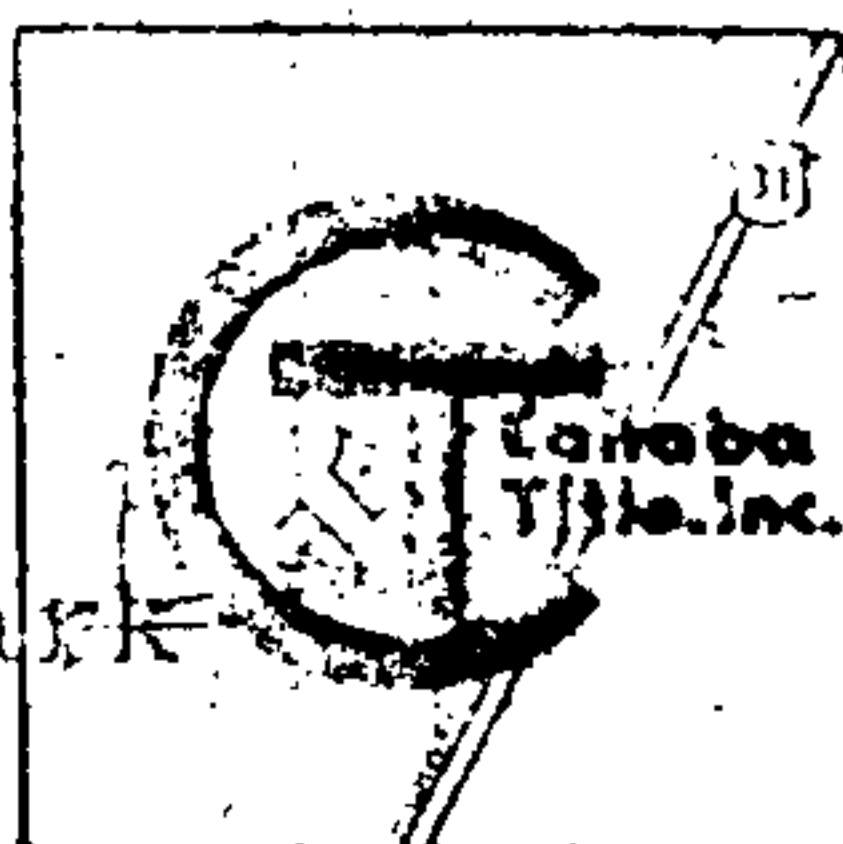

 COUNTY OF SHELBY } KNOW ALL MEN BY THESE PRESENTS,

That in consideration of Thirty Thousand and no/100-----dollars

to the undersigned grantor, Chandalar Dev., Inc. a corporation,  
 (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the  
 said GRANTOR does by these presents, grant, bargain, sell and convey unto

Kirby C. Leeper and wife, Peggy D. Leeper

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor  
 of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate,  
 situated in Shelby County

Lot 185, according to the survey of Chandalar South, Fourth Sector,  
 as recorded in Map Book 6 Page 69 in the Probate Office of Shelby  
 County, Alabama.

Subject to easements and restrictions of record.

And as further consideration the grantees herein expressly assume  
 and promise to pay that certain mortgage to First Southern Federal  
 Savings & Loan Association recorded in the Mortgage Book 374, page 947,  
 in the Probate Office, according to the terms and conditions of said
