KNOW ALL MEN BY THESE PRESENTS, That the undersigned SOUTHERN NATURAL GAS COMPANY (Grantor herein), a Delaware corporation, for and in consideration of the sum of TEN AND NO/100 DOLLARS (\$10.00) to it in hand paid by ELECTRICAL SPECIALTY PRODUCTS CO. (Grantee herein), an Alabama corporation, the receipt whereof is acknowledged, does hereby grant, bargain, sell and convey, insofar as it has the right to grant, bargain, sell and convey, without any warranty or representation of its right to do so, and subject to any existing or future mortgages of Grantor, to Grantee, its successors and assigns, a right of way and easement 25 feet in width for the purpose of constructing, using, repairing and maintaining an asphalt surfaced Co driveway or roadway for vehicular access to plant and shipping facilities of Grantee, said right of way being located in Shelby County, Alabama, and being more particularly described as follows:

> A strip of land 25 feet in width and 210 feet in length, constituting the northwesternmost 25 feet of that certain tract or parcel of land described in deed made in favor of Southern Natural Gas Company by Jesse Lee Sellers, et ux, dated July 16, 1956, and recorded in Deed Book 181 at Page 244 in the Office of the Judge of Probate, Shelby County, Alabama, said strip of land located, lying and being in the Southwest Quarter of the Southeast Quarter (SW 1/4 of SE 1/4) of Section 4, Township 24 North, Range 12 East, Shelby County, Alabama; all as more fully shown and marked in red on Southern Natural Gas Company Drawing No. V-294, copy of which is attached hereto, marked "Exhibit A" and made a part hereof.

The term of this easement grant shall be for a period of fifty (50) years, from April 9, 1980 to April 9, 2030, upon which latter date all rights hereunder shall terminate and ipso facto revert to Grantor herein.

Grantee is hereby granted the above mentioned rights to have and to hold for the term hereof, for the uses and purposes aforesaid together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof; provided however, that Grantee's exercise of such rights shall in no way interfere with Grantor's existing or future operations on Grantor's land.

Grantor also reserves unto itself, its successors and assigns, full and free right and authority otherwise to use and enjoy the premises for and in a manner that will not unreasonably interfere with the easement rights herein granted Grantee.
