
## MORTGAGE RELEASE

described below released from said mortgage and said E. R. Elliott
desires to accept said consideration
for the releasing of said property and agrees to release said land
from said mortgage;
Now, therefore, the undersigned E. R. Elliott and Betty
in consideration of One
Dollars, being paid to said E. R. Elliott and
Betty Elliott in hand paid by the said Ralph W. Thomas and
Sue H. Thomas the receipt whereof is hereby acknowledged,
does hereby release, remise and quit claim unto the said Ralph W.
Thomas and Sue H. Thomas all the right, title and interest
acquired under said mortgage in and to that part of the premises
conveyed therein, and described as follows, to-wit:

Commence at the Southeast corner of the SW% of NE%, Section 28, Township 19, Range 1 East as established by survey dated May 15, 1974; thence run West along the South line of said ½-½ section a distance of 200 feet to a point; thence run due North a distance of 80 feet, more or less, to the South ROW line of new U. S. Highway No. 280; thence run in a Northeasterly direction along the South ROW line a distance of 205 feet, more or less to the East line of said ½-½ section; thence run South along the East line of said ½-½ section a distance of 105 feet, more or less, to the point of beginning.

TO HAVE AND TO HOLD to the said Ralph W. Thomas and their heirs

Sue H. Thomas and to xitax successors and assigns forever.

It is understood and agreed that this release shall not in any way impair or affect the right of the said mortgages to hold the remainder of the premises conveyed in said mortgage and not hereby released as security for that part of the mortgage indebtedness remaining unpaid on said mortgage.
