GARRETT and wife, AUDREY GARRETT; and GARY S. GARRETT and wife, JOYCE GARRETT, (herein referred to as grantors, whether one or more), grant, bargain, sell and convey unto HERMAN A. GARRETT and HARVEY E. GARRETT, (herein referred to as grantees, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

The NE% of the SW% and NW% of the SE% of Section 34, Township 18, Range 2 East.
