AFFIDAVIT OF JOHN T. DISSON

I am John T. Disson and I am 80 years of age. In 1947, I and my wife, Bessie J. Disson, purchased a parcel of land located in Shelby County, Alabama, more particularly described as follows:

A parcel of land located in the SW% of the SE% of Township 19 South, Range 3 West, of the Huntsville principal meridian, more particularly described as follows: Commence at the southwest corner of the SW% of the SE% of said Section 24, thence East along the South line of said quarter-quarter section a distance of 630 feet; thence 90 deg. 54 min. left a distance of 210 feet to the point of beginning; thence continue along the last mentioned course 210 feet; thence 90 deg. 54 min. to the right a distance of 210 feet; thence 89 deg. 06 min. to the right a distance of 210 feet; thence 90 deg. 54 min. right a distance of 210 feet to the point of beginning. Mineral and mining rights excepted.

On October 10, 1965, I and my wife, Bessie J. Disson, executed a mortgage in the amount of One Thousand One Hundred Forty Seven and 40/100 Dollars (\$1,147.40) using the above-described property as collateral. That mortgage was recorded on October 10, 1965, in Mortgage Book 297, Page 204, and later assigned to Affliated Investments, Inc., under Deed Book 243, Page 60, in the Office of the Judge of Probate of Shelby County, Alabama.

I made the mortgage for the construction of a home on the property to be constructed by Leeds Homes, Inc., of Bessemer, Alabama, and payable at the rate of Fifty Seven and 37/100 Dollars (\$57.37) monthly for 60 months.

During the term of this mortgage, the mortgage company was sold and changed ownership and the last company to which I made payments was Bradley Mortgage Company, at 127 North State, Jackson, Mississippi. I do not recall the exact date this mortgage was paid in full but I believe it was paid off in 1967.

My wife, Bessie J. Disson, died on January 31, 1980. I do not owe any corporation or other legal entity any further sums of money and I have paid off all montgages and liens on or against my property.
