SUBLEASE AND ASSIGNMENT

This SUBLEASE AND ASSIGNMENT, dated as of the 7th day of May, 1981, by and between PELMAR, LTD. (here-in called "Pelmar"), an Alabama limited partnership, and MARVIN'S INC., a corporation organized under the laws of the State of Delaware (herein called "Marvin's")

RECITALS:

Section 1. <u>Sublease of the Project</u>. Pursuant to Section 9.1 of the Lease, Pelmar does hereby sublease the Project to Marvin's, on all of the terms and conditions contained in the Lease. Marvin's hereby accepts said sublease, and agrees to perform all the obligations of Pelmar under the Lease.
