PARCEL A: Begin at the Northwest corner of Section 13, Township 20 South, Range 4 West; thence run east along the north line of said section, 281.0 feet to the point of beginning of said PARCEL "A"; thence proceed east along the previous course, 221.28 feet; thence turn right 45 degrees 49 minutes southeasterly 271.64 feet; thence turn right 44 degrees 45 minutes southwesterly, 189.41 feet to a point on the chord of a curve to the left on the north R.O.W. of South Shades Crest Road, said curve having a radius of 1089.07 feet and a central angle of 13 degrees 24 minutes; thence turn right 53 degrees 03 minutes southwesterly along the said north R.O.W. of said road along a segment of the chord 25.55 feet to the southwest corner of said Parcel "A"; thence turn right 82 degrees 12 minutes northwesterly 556.91 feet to the point of beginning.

PARCEL B: Begin at the northwest corner of Section 13, Township 20 South, Range 4 West; thence run east along the north line of said section, 502.28 feet; thence turn right 45 degrees 49 minutes southeasterly 271.64 feet to the point of beginning of said Parcel "B"; thence proceed southeasterly along the previous course 152.8 feet to a point on the northerly R.O.W. of South Shades Crest Road, said point being the P.T. of a curve to the left, said curve having a radius of 1089.07 feet and a central angle of 13 degrees 24 minutes; thence turn right 97 degrees 48 minutes southwesterly along a chord on said curve along said R.O.W. 134.60 feet to a point on said chord, said point being the southwest corner of said PARCEL "B": thence turn right 126 degrees 57 minutes northeasterly 189.41 feet to the point of beginning. 
