KNOW ALL MEN BY THESE PRESENTS: That I, Ellen U. Lowe, of the City of Selma, County of MONTGOMERY State of AL have made, constituted and appointed, and by these presents do make, constitute, and appoint Richard M. Lowe my true and lawful attorney for me and in my name, place and stead, and for my use and benefit, to ask, demand, sue for, recover, collect and receive all such sums of money, debts, dues, accounts, legacies, bequests, interests, dividends, annuities and demands whatsoever as are now, or shall hereafter become due, owing, payable or belonging to me, and have, use and take all lawful ways and means in my name or otherwise for the recovery thereof, by attachments, arrests, distress or otherwise, and to compromise and agree for the same, for me, and in my name, to make, seal, and deliver; to bargain, contract, agree for, purchase, receive, and take lands, tenements, hereditaments and accept the seizing and possession of all lands and all deeds and other assurances, in the law therefor, and to lease, let, demise, bargain, sell, remise, release, convey, mortgage, and hypothecate lands, tenements, and hereditaments, upon such terms and conditions, and under such covenants, as he shall think fit. Also to bargain and agree for, buy, sell, mortgage, hypothecate and in any and every way and manner deal in and with goods, wares, and merchandise, choses in action and other property in possession or in action, and to make, do, transact all and every kind of business of what nature or kind soever, and also for me and in my name, and as my act and deed, to sign, seal, execute, deliver and acknowledge such deeds, leases, and assignment of leases, covenants, indentures, agreements, mortgages, bills of lading, bills, bonds, notes, receipts, evidences of debts, releases and satisfaction of mortgage, judgments and other debts, and such other instruments in writing of whatever kind and nature as may be necessary or proper in the premises.

Also to receive all policies of insurances, stock certificates, bonds, deeds and any and all other kinds of evidences of indebtedness which may exist between myself and any other person, firm or corporation whatsoever and I do hereby authorize the said Richard M. Lowe to receive in my name any and all kinds of information, documents, instruments or letters to which I may be entitled.

My attorney is hereby authorized legally to sell, buy, mortgage, exchange, and in any wise legally to dispose of any and all property, real, personal and mixed, belonging to the undersigned, wherever located.

And I, the said Ellen U. Lowe do hereby ratify and confirm all whatsoever my said attorney, or his substitute, or substitutes, has done, shall do, or cause to be done, on or about the premises, by virtue of this power of attorney.




