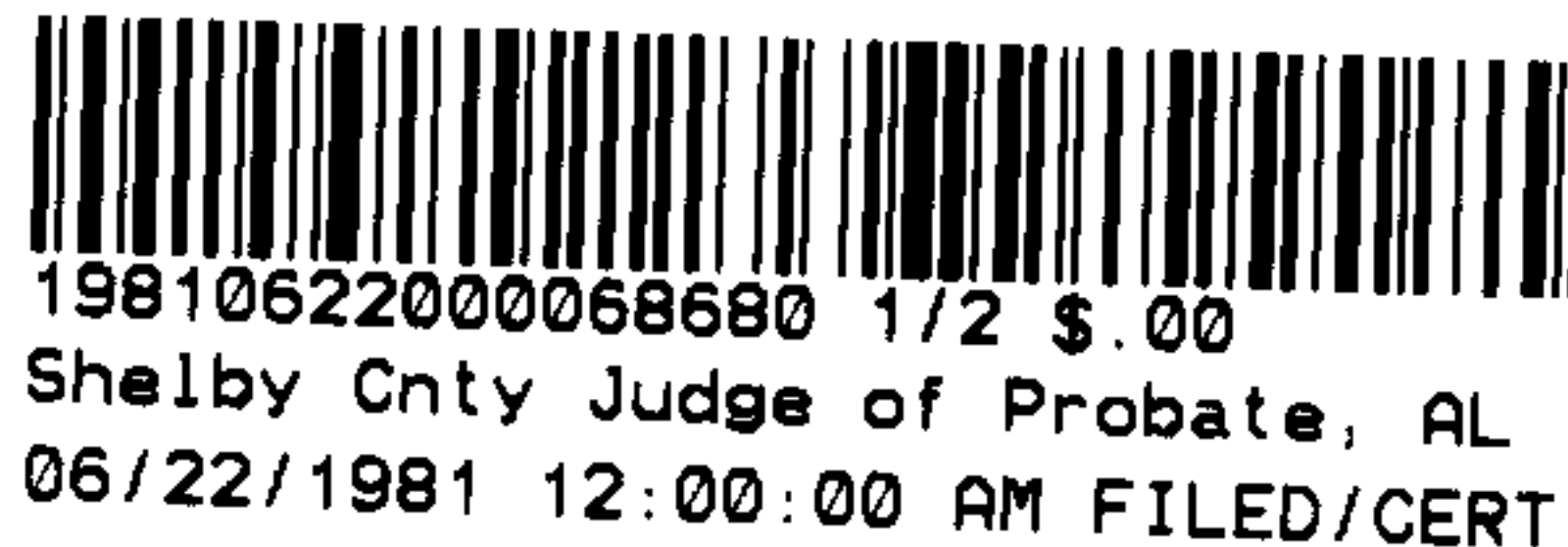

AFFIDAVIT OF ERNEST WRIGHT

I am Ernest Wright and I am married to Mary Lee Wright and my fathers name is Will Wright. In 1945 my father purchased some land from Mr. S. W. Pardue, known as Sam Pardue, who has been dead ten to fifteen years. It is my understanding that Mr. Pardues wife is now deceased. In 1947, my father mortgaged this land back to Mr. Pardue and during his lifetime paid this loan off.

In reference to Parcel I as shown at the bottom of this Affidavit, I have lived on this land since 1946 and I know that my father paid the taxes on it up until his death. My mother and father are both deceased and I was the only child born of their marriage. I know of no other marriages that my mother and father had other than to themselves. Since my fathers death, I have been paying the taxes on the entire tract. In 1973, I conveyed to my son-in-law and daughter, Daniel Wooley and wife, Brenda Wooley a portion of this land more legally described as follows:

A lot or parcel of land situated in the E. 1/2 of the S.E. 1/4 of Section 2, Township 21 South, Range 3 West, more particularly described as follows:  
Commence at the point of intersection of the East line of the above said Section 2 and the easterly right of way line of Old Alabama Highway No. 31 for a point of beginning. Thence run North along said section line for a distance of 385.0' feet, thence run West for a distance of 175.0' feet, more or less, to a point on said highway right of way, thence run in a Southeasterly direction along said highway to the point of beginning. Situated in Shelby County, Alabama.

Since that date, Daniel Wooley and my daughter, Brenda Wooley, have built a Jim Walter house which has been sold to Mid-State Homes. During the time they have paid their mortgages on the land and paid the taxes on this separate parcel. I know of no one in the last thirty-four years that has claimed any interest in this land and we have lived on this entire land up until 1973 at which time I gave part to my daughter and her husband, Brenda Wooley and Daniel Wooley, to build their house on.
