TURNER and wife, BETTY JEAN TURNER; WILLIAM I.

TURNER and wife, SARA JO TURNER; LLOYD M. TURNER, an unmarried man;

EMOJENE BARNES and husband, JOSEPH D. BARNES; and BILL BEATTY, an unmarried man (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto RUBY J. CLINKSCALES (herein referred to as grantee, whether one or more), the following described real estate, situated in SHELBY County, Alabama, to-wit:
