A parcel of land located in the NW 1/4 of the NE 1/4 of Section 12, Township 20 South, Range 3 West, Shelby County, Alabama, more particularly described as follows:

Commence at the Northeast corner of said 1/4-1/4 Section; thence in a Southerly direction along the East line of said 1/4-1/4 Section a distance of 469.3 feet to the intersection of the Northwest right of way line of U.S. Highway 31; thence 27 deg. 24' right in a Southwesterly direction along said right of way line a distance of 438.95 feet to the point of beginning; thence continue along last described course a distance of 75.05 feet; thence 90 deg. right in a Northwesterly direction a distance of 180.0 feet; thence 77 deg. 18' 39" right in a Northerly direction a distance of 181.99 feet; thence 122 deg. 27' 21" right and being tangent to a curve to the left, said curve having a central angle of 19 deg. 46' and a radius of 230.57 feet; thence along arc of said curve in a Southeasterly direction a distance of 79.55 feet to end of said curve and the beginning of a curve to the right, said curve having a central angle of 57 deg. 19' 22" and a radius of 164.0 feet; thence along arc of said curve in a Southeasterly direction a distance of 164.08 feet to end of said curve and the beginning of a curve to the right, said curve having a central angle of 32 deg. 40' 38" and a radius of 25.0 feet; thence along arc of said curve in a Southerly direction a distance of 14.26 feet to end of said curve and the point of beginning.
