WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR-

STATE OF ALABAMA }  
Shelby COUNTY } KNOW ALL MEN BY THESE PRESENTS,

That in consideration of Thirty Thousand and no/100 ----- DOLLARS

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,  
William R. Rotenberry and wife, Julia W. Rotenberry

(herein referred to as grantors) do grant, bargain, sell and convey unto

Fred Joseph Miller, III and Connie Walton Miller  
(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor  
of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated  
in Shelby County, Alabama to-wit:

Lot 2, in Block I, according to Lyman's Addition to the Town of  
Montevallo, Alabama, as shown by map of said Lyman's Addition on  
record in the Probate Office of Shelby County, Alabama, in  
Map Book 3, Page 27.

Subject to Public Utility easements servicing said subdivision.

\$28,000.00 of the above recited purchase price was paid from a  
mortgage executed simultaneously herewith.

TO HAVE AND TO HOLD to the said GRANTEES for and during their joint lives and upon the death of either of them,

remainder and right of reversion.

against the lawful claims of all persons.
