That in consideration of One and no/100 Dollar and other good and valuable consideration to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, HAROLD JEROME TURNER and wife, MARY ANN TURNER; EUNICE TURNER, a widow; THOMAS D. TURNER and wife, BETTY JEAN TURNER; WILLIAM I. TURNER and wife, SARA JO TURNER; LLOYD M. TURNER, an unmarried man; RUBY J. CLINKSCALES and husband, E. M. CLINKSCALES; EMOJENE BARNES and husband, JOSEPH D. BARNES; and BILLY BEATTY, an unmarried man (herein referred to as grantors), do grant, bargain, sell and convey unto EMOJENE BARNES and JOSEPH D.
