

NOTICE OF PUBLIC HEARING ON PETITION OF
ALABAMA POWER COMPANY FOR DESIGNATION OF
CERTAIN LANDS LOCATED IN SHELBY COUNTY, ALABAMA,
AS AN INDUSTRIAL PARK UNDER THE
PROVISIONS OF ACT NO. 604 ADOPTED BY THE
LEGISLATURE OF THE STATE OF ALABAMA ON MAY 1, 1978

Notice is hereby given that a public hearing on
the above described petitioner will be held in the office of
the County Commission of Shelby County, at the Shelby County
Courthouse, Columbiana, Alabama, at 10 o'clock,
A m. on the 7th day of December, 1981. The
description of the tract of land which is requested to be
designated as an Industrial Park is as follows:

A parcel of land situated in the South 1/2 and the
West 1/2 of the Northeast 1/4 of Section 29; the North 1/2,
of the Northeast 1/4, the Southwest 1/4 of the Northeast
1/4, the Northwest 1/4 of the Southeast 1/4, the Northeast
1/4 of the Northwest 1/4 of Section 32; the Northwest 1/4 of
the Northwest 1/4 of Section 33, all in Township 21 South,
Range 2 West, Shelby County, Alabama being more particularly
described as follows:

Begin at the Southeast corner of the Northwest
1/4 of the Southeast 1/4 of Section 32, Township 21 South,
Range 2 West, Shelby County, Alabama; thence run North 88°
21' 33" West along the South boundary of said 1/4-1/4 section,
a distance of 1110.99 ft. to a point on the Northeasterly
boundary of Interstate Highway 65; thence turn right and run
North 24° 8' 13" West a distance of 424.30 ft. to a point on
the West boundary of said Northwest 1/4 of the Southeast
1/4; thence turn right and run North along the West boundary
of said 1/4-1/4 section and along the West boundary of the
West half of the Northeast 1/4 of Section 32 a distance of
2946.77 ft. to a point; thence turn left and run North 18°
09' 44" West a distance of 1102.68 ft. to a point; thence
turn left and run North 53° 4' 31" West a distance of 370.0
ft. to a point; thence turn left and run North 88° 4' 31"
West a distance of 220.0 ft. to a point; thence turn right
and run North 33° 35' 7" West a distance of 824.02 ft. to a
point; thence turn left and run North 44° 39' 57" West a
distance of 87.33 ft. to a point; thence turn right and run
North 01° 22' 13" West a distance of 538.22 ft. to a point;
thence turn left and run South 88° 37' 47" West a distance
of 236.81 ft. to a point on the Easterly boundary of Shelby
County Road # 87; thence turn right and run North 07° 6' 22"
West along the chord of a curve to the left a distance of
76.40 ft.; thence turn left and run South 77° 1' 44" West a
distance of 50.0 ft. to a point; thence turn right and run
North 16° 5' 10" West along the chord of a curve to the left
a distance of 35.19 ft. to a point; thence turn right and
run North 88° 37' 47" East a distance of 302.36 ft. to a
point on the West boundary of the Northeast 1/4 of the
Southwest 1/4 of Section 29; thence turn left and run North
01° 22' 13" West along the West boundary of said 1/4-1/4
Section a distance of 645.76 ft. to the Northwest corner of
said 1/4-1/4 Section; thence turn right and run South 87°
54' 28" East along the North boundary of said 1/4-1/4 section
a distance of 1364.69 feet to a point; thence turn left and
run North 00° 50' 46" West a distance of 2067.18 feet to a
point on the Southwesterly right-of-way boundary of the

Louisville and Nashville Railroad; thence turn right and run South 24° 52' 25" East along the Southwesterly railroad right-of-way boundary a distance of 6812.47 feet to the point of intersection with the South boundary of the Northwest 1/4 of the Northwest 1/4 of Section 33; thence turn right and run West along the South boundary of said 1/4-1/4 Section and along the South boundary of the Northeast 1/4 of the Northeast 1/4 of Section 32 a distance of 1447.1 ft. to a point; thence turn left and run South 00° 15' 34" East along the East boundary of the Southwest 1/4 of the Northeast 1/4 and along the East boundary of the Northwest 1/4 of the Southeast 1/4 of Section 32 a distance of 2688.26 ft. to the point of beginning. Containing 340.837 acres.
