Rowan a widower, who conveyed the real property to Elvie Lamar Rodgers by Warranty deed dated 12-22-29, and recorded in Deed Book 3047, Page 475 on January 22, 1940, in the Office of the Judge of Probate, Jefferson County, Alabama, at Birmingham, Alabama.

RECITAL: The purpose of this deed is to convey an undivided 2 acres (a 1/38th interest-undivided) to each of the four grantees, as was done by deeds recorded in Deed Book 323, Pages 25, 26, 27, and 28, Office of the Judge of Probate, Shelby County, Alabama, at Columbiana, Alabama, and corrected by affidavit recorded in Book 36, Page 27, same office. 
