1. The name of this corporation shall be:

2. The object and purpose of this corporation shall be:

to sell, distribute and service mail handling systems, including the rebuilding, redesigning and repairing of all types of equipment used for the handling of mail of individuals, corporations or partnership; and to do any and all other legal acts to carry out the purpose of the corporation.

3. The principal office of said corporation shall be located at 1408 Alexander Coutny, Alabaster, Shelby County, Alabama, 35007.

4. The capital stock of said corporation shall be One Thousand Dollars (\$1,000.00), divided into one thousand (1,000) shares of common stock, each share to have a par value of One Dollar (\$1.00).




