LESS AND EXCEPT THE FOLLOWING: From the most northerly corner of said Lot 24-A (being a common corner with Lot 25-A) run in a southeasterly direction along the common line between Lots 24-A and 25-A for a distance of 57.33 feet to the point of beginning, thence turn an angle to the left of 3°49' and run in an easterly direction for a distance of 35.05 feet, thence turn an angle to the right of 6°59'30" and run in a southeasterly direction for a distance of 42.05 feet, thence turn an angle to the left 9°12'08" and run in an easterly direction for a distance of 42.22 feet, thence turn an angle to the left of 35°55'46" and run in a northeasterly direction for a distance of 60.74 feet, thence turn an angle to the right of 15°00'45" and run in an easterly direction for a distance of 51.61 feet, more or less, to the most easterly corner of Lot 25-A thence turn an angle to the right and run in a southwesterly direction along the common line of said Lots 24-A and 25-A for a distance of 117.22 feet to a common corner of said Lots 24-A and 25-A thence turn an angle to the right and run in a northwesterly direction along the common line of said Lots 24-A and 25-A for a distance of 114.95 feet, more or less to the point of beginning.
