ORDER

Upon submission of plaintiffs' Motion for Summary Judgment, the Court finds there is no material issue of fact and plaintiff is entitled to judgment as a matter of law. Principal on the subject note in the amount of \$9,176.00 remains unpaid. Unpaid accrued interest to date amounts to \$1,352.66. An attorney's fee in the amount of 20 % of the unpaid sum is appropriate.

It is therefore, ORDERED:

1. Judgment is rendered in favor of plaintiffs against defendant in the amount of \$ 12,634<sup>39</sup>.

2. The unpaid judgment shall bear interest at the rate of 12% (9PM) per annum.

3. Defendant has waived rights of exemption under the law.

4. Costs taxed against defendant.
