hereby remises, releases, quit claims, grants, sells, and conveys to  
Thelma Marie Scott

(hereinafter called Grantee), all their right, title, interest and claim in or to the fol-  
lowing described real estate, situated in Shelby County, Alabama, to-wit:

That certain tract of land described as beginning at a point 453 feet North of  
the SW corner of the NE 1/4 of SE 1/4 of Section 5, Township 22, Range 3 West and  
run North 15 rods to a gas pipe two inches in diameter driven in the ground;  
run thence East 28 rods to a gas pipe driven in the ground on the West side  
of the Montevallo and Dogwood road; run thence South on the West side of the  
Montevallo and Dogwood road 354 feet to a gas pipe; run thence Northwesterly  
along the Little Gem Coal Company's mining track and on the North side thereof  
to the point of beginning, containing 2 acres, more or less.

Also, the surface rights to a tract of land described as starting at the NE  
corner of the NW 1/4 of SE 1/4 of Section 5, Township 22, Range 3 West, and run thence

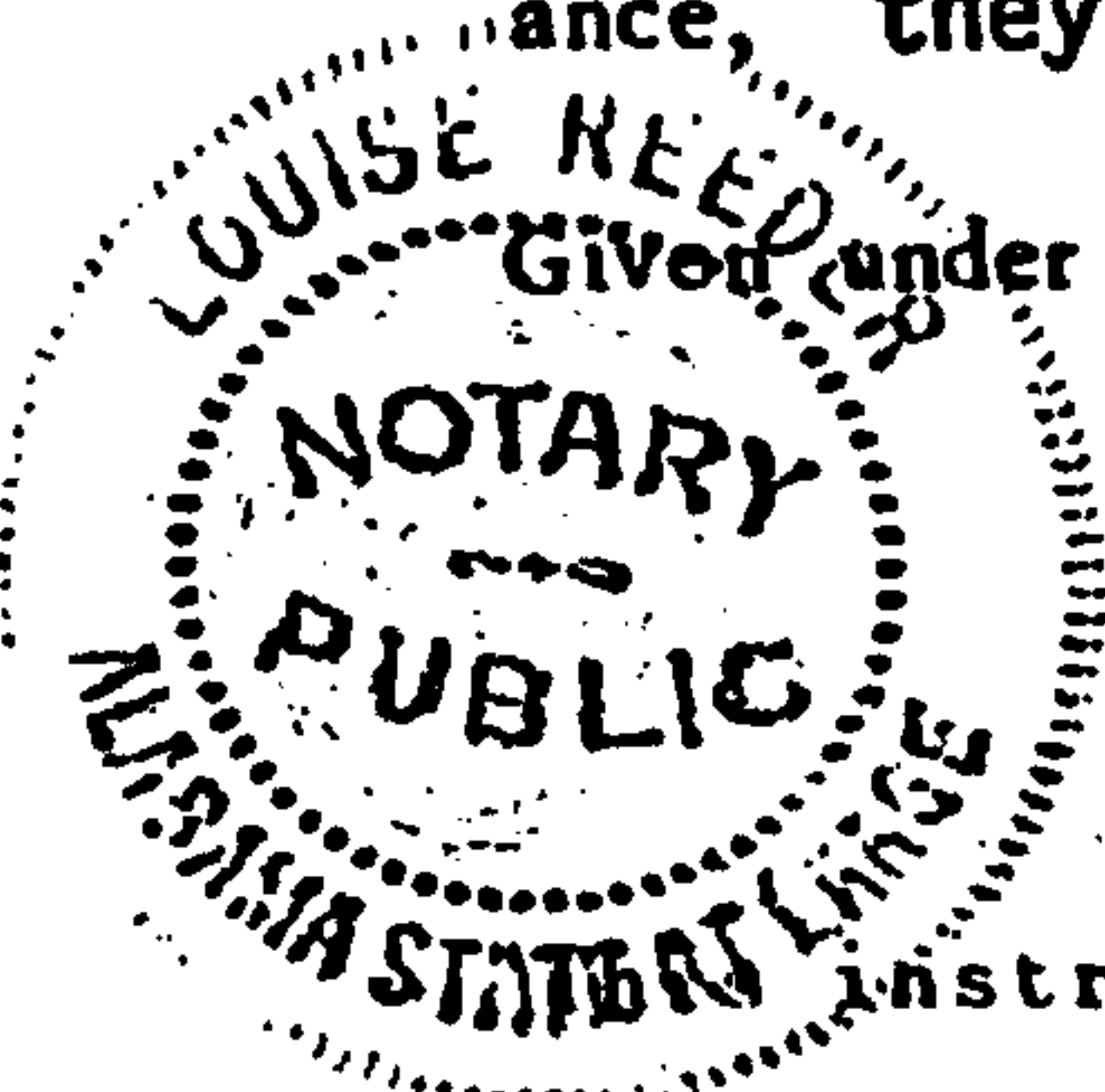
