KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of ONE THOUSAND, EIGHT HUNDRED AND NO/100 -- (\$1,800.00) DOLLARS and other good and valuable consideration in hand paid by MONROE H. JOHNSON, III AND WIFE, LOUISE A. JOHNSON, (hereinafter referred to as "GRANTEE") to CENTRAL BANK OF THE SOUTH, an Alabama Banking Corporation (hereinafter referred to as "GRANTOR") the receipt whereof is hereby acknowledged, the said GRANTOR does by these presents grant, bargain, sell and convey unto the said GRANTEE, for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:
