5/13/82 This matter came before the Court today for consideration of consent judgment. A Consent to Judgment has been duly executed by the defendants in this case. One of the parties to this case is a minor who at the time of the alleged incident was a 21 months old child. The case is rather unique in that the Court is advised that the legal wrong charged against the defendants is that said minor plaintiff was spanked while in the care of the defendants. The Court finds there is no medical injury and from having interrogated the father of the minor child, is satisfied that the child had no physical injuries. The damages claimed basically are punitive in nature and the Court after considering all the facts as well as the consent of the defendants to judgment, finds that the judgment in the amount of \$5,000.00 in favor of the minor plaintiff, Amanda Christine Gibbs, and \$5,000.00 in favor of the father, Larry Mack Gibbs, to be a reasonable and fair settlement and a settlement to the best interests of said minor child. Judgment is therefore entered in favor of said minor plaintiff, Amanda Christine Gibbs, against the defendants in the sum of \$5,000.00 and judgment is also entered in favor of the plaintiff, Larry Mack Gibbs, and against the defendants in the sum of \$5,000.00. all costs of court are taxed against the defendants.
