The purpose of this corporation shall be charitable, literary and cultural; to create public interest in the Alabaster Free Public Library in the city of Alabaster, Shelby County, Alabama; to promote increased knowledge and understanding of its services and needs; and to foster public support for the necessary development of said Library to the end that it may serve adequately the needs of the steadily increasing population of said city.
- III. All persons and organizations who desire to as:
 in promoting the object of this corporation and are found III. All persons and organizations who desire to assist otherwise qualified by the Poard of Directors may become members of this corporation in the manner from time to time provided by its Ey-Laws.
 - IV. This corporation shall have perpetual existence.
