located and described as follows, to-wit: and as shown on the right-of-way map of Project No. F-248(17) as recorded in the Office of the Judge of Probate of Shelby County, Alabama:

Commencing at the southwest corner of the SW $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 28, T-19-S, R-2-E; thence easterly along the south line of said SW $\frac{1}{4}$ of SE $\frac{1}{4}$ a distance of 1180 feet, more or less, to the west property line; thence northerly along said west property line a distance of 51 feet, more or less, to the point of beginning of the property herein to be conveyed, said point of beginning being on a line which extends from a point that is 40 feet southerly of the traverse of a paved county road at Station 25+00 to a point that is 40 feet southerly of and at right angles to said traverse at Station 21+00; thence easterly along said line a distance of 16 feet, more or less, to said point that is 40 feet southerly of and at right angles to said traverse at Station 21+00; thence southeasterly along a line (which if extended would intersect a point on the present southwest right-of-way line of U.S. Highway No. 280 that is southwesterly of and at right angles to the centerline of Project No. F-248(17) at Station 1127+25) a distance of 14 feet, more or less, to the east property line; thence northerly along said east property line a distance of 14 feet, more or less, to the present south right-of-way line of said paved county road; thence westerly along said present south right-of-way line a distance of 30 feet, more or less, to the west property line; thence southerly along said west property line a distance of 10 feet, more or less, to the point of beginning.
