CONSENT TO DISSOLVE

The undersigned, being shareholders of capital stock in Robinson Grassing Company, Inc., do hereby agree and give written consent to the dissolution of that corporation, organized and existing under the laws of the State of Alabama.

The undersigned agree to abide by and/or effect all of the elements and requirements of both the Statement of Intent to Dissolve Robinson Grassing Company, Inc., and the proposed Articles of Dissolution for that corporation; the latter document currently lacks only the date of filing the former document.

Upon the issuance of a Certificate of Dissolution, the existence of Robinson Grassing Company, Inc., shall cease, except for the purpose of suits, other proceedings and appropriate corporate action by shareholders, directors and officers as provided for by law.
