

AFFIDAVIT

Before me, the undersigned authority in and for said County, in Said State, personally appeared Ruby Elizabeth Hodgens who after first being by me duly sworn to speak the truth, deposes and says:

My name is Ruby Elizabeth Hodgens I am 52 years of age and am a resident citizen of Shelby County, Alabama.

I was personally acquainted with Nellie K. Hodgens, who died on July 5, 1978 in Shelby County, Alabama. I know of my own personally knowledge that Nellie K. Hodgens' next of kin were: Louise Tumlin; Marlin Hodgens and R. J. Hodgens. I was personally familiar and had personal knowledge of the real estate owned by Nellie K. Hodgens at the time of her death.

It is of my own personally knowledge that the following described property was part of the 15 acres which was Willed to R. J. Hodgens by that certain Will of Nellie K. Hodgens which was dated July 6, 1976 and which was filed for probate on the 26th day of February, 1979, in the Probate Office of Shelby County, Alabama. Said Estate was closed out on February 10, 1982.

Said land is described as follows:

The South 4.005 acres of the West 1/2 of West 1/2 of SE 1/4 of NE 1/4, Section 2, Township 20 South, Range 2 West, more particularly described as commencing at the NW corner of said 1/4-1/4 section; thence run South along the West line of said 1/4-1/4 Section for 779.94 feet to the point of beginning; thence continue South for 539.00 feet to the SW corner of said 1/4-1/4 Section; thence 90 deg. 16 min. left and run easterly for 323.12 feet; thence 89 deg. 36 min. 30 sec. left and run northerly for 539.00 feet; thence 90 deg. 23 min. 30 sec. left and run westerly for 324.30 feet to the point of beginning. Said parcel contains 4.005 acres, more or less. Being Situated in Shelby County, Alabama.
