That certain Contract of Sale created by Bowater, as successor to Hiwassee Land Company, giving Travelers Notice on the many of its intention to exercise the option to purchase the lands covered by and included under the abovementioned Lease and the timber thereon granted to Bowater, as the successor to Hiwassee Land Company, by the provisions of Paragraph 4 of the above-mentioned Lease.
