**WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR**

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of Five Thousand and No/100 (\$5,000.00) to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged we, A. V. COKER, W. M. DOLLARS, and CLAUDE MOORE, as Trustees constituting the State Board of Trustees of the Church of God for the State of Alabama with State Headquarters in Jefferson County, in said State, (herein referred to as Grantors) do grant, bargain, sell and convey unto ✓ CALVIN MEADOWS, and BEVERLY J. MEADOWS, his wife, (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot number Four (4), in block three (3) of the town of Aldmont, according to the survey and map of said town of Aldmont, as recorded in the office of the Probate Judge of Shelby County, Alabama.
