AFFIDAVIT

Before me, the undersigned, a notary public in and for said State and said County, personally appeared Lucille Gentry Campbell, affivant, and being duly sworn, deposes and says as follows:

That my name is Lucille Gentry Campbell and I reside at Detroit, Michigan.

I am the natural daughter of John Odis Gentry and Lela Mae Gentry. My mother and father had eleven children, namely, Clinton Gentry, Pearlle Gentry, R. C. Gentry, W. M. Gentry, Ployd Gentry, John Gentry, Thomas Charles Gentry, John Henry Gentry, Bessie Mae Gentry, Gussie Mae Gentry Oden, and myself, Lucille Gentry Campbell. During the lifetime of my mother and father they were the joint owners of a piece of property described as follows:

Five acres of land in a square in the SW corner of the SW 1/4 of the SE 1/4 of Section 36, Township 20, Range 3 West, situated in Shelby County, Alabama.

The above described property and ownership to the same are shown by deed recorded in Deed Book 221, Page 794 in the Probate Office of Shelby County, Alabama. My mother, Lela Mae Gentry, died in December, 1953. My father, John Odis Gentry, died in November, 1955. One of my sisters, namely, Bessie Mae Gentry, predeceased my parents, leaving no living issue. Between the death of my parents and the signing of this Affidavit seven of my brothers and sisters have died, namely, R. C. Gentry, W. M. Gentry, Ployd Gentry, John Gentry, John Henry Gentry, Thomas Charles Gentry, and Pearlle Gentry. At the time of the death of my brother, R. C. Gentry, he was married to Annie B. Gentry and they had no children. My brother, W. M. Gentry, was divorced at the time of his death and had no living issue. My brother, Ployd Gentry, was survived by his wife, Lydia Gentry, and five (5) children, namely, Ms. Evelyn Gentry Stokes, Leon Gentry, Elizabeth Stokes Robinson, Cleo Gentry, and Billy Gentry. My brother, John Gentry, died leaving no living issue. My brother, Thomas Charles Gentry was survived by his wife, Betty Peoples and his five children, namely Cynthia Green and Thomas C. Gentry, Jr., Karen Sue Gentry, Michael Gentry and Jeffrey Gentry. My sister, Pearlle Gentry was unmarried at the time of her death and was survived by one (1) son, namely, Luther Shealey, a widower.

At the present, there are three children surviving, namely, Clinton Gentry, Gussie Mae Oden and myself, Lucille Gentry Campbell. Clinton Gentry is currently married to Annie Ruth Gentry and they have no children. Gussie Mae Oden is a widow and I, Lucille Gentry Campbell am divorced.
