STATUTORY WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the exchange of like kind lands conveyed to GULF STATES PAPER CORPORATION by CHARLES H. THORNBURG, SR., the receipt and sufficiency whereof are hereby acknowledged, the undersigned Grantor, GULF STATES PAPER CORPORATION, a corporation, does by these presents, grant, bargain, sell and convey unto CHARLES H. THORNBURG, SR. (herein referred to as Grantee), the following described real estate situated in Shelby County, Alabama, to-wit:

SURFACE RIGHTS ONLY TO:

A part of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 18, Township 22 South, Range 1 East, in Shelby County, Alabama; said parcel being more particularly described as follows: To find the point of beginning, commence at the Southeast Corner of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 18; thence run in a Northerly direction and along the East boundary of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ for a distance of 354 feet to its intersection with the North boundary of the Cemetery; thence run in a Westerly direction and along the North boundary of said Cemetery for a distance of 316.7 feet to the Northwest Corner of said Cemetery, said point also being the point of beginning of the property described herein; thence run in a Southwesterly direction and along the West boundary of said Cemetery for a distance of 397.05 feet to a point; thence with a deflection angle of 59°-42' right, run in a Westerly direction for a distance of 308.07 feet to a point, said point lying 271.24 feet North of the Northeast Corner of Block 136 of the Town of Shelby; thence with a deflection angle of 92°-38' right, run in a Northerly direction for a distance of 231.79 feet to a point on the South Right-of-Way margin of the Old L & N Railroad; thence with a deflection angle of 63°-53' right, run in a Northeasterly direction and along the South Right-of-Way margin of said Railroad for a distance of 188.56 feet to a point; thence with a deflection angle of 4°-39' right, continue in a Northeasterly direction and along the South Right-of-Way margin of said Railroad for a distance of 400.74 feet to a point; thence with a deflection angle of 139°-08' right, run in a Southwesterly direction for a distance of 108.03 feet to the point of beginning, said parcel containing 3.05 acres, more or less.

Grantor reserves unto itself, its successors or assigns, all oil, gas, mineral and mining rights that it may own.
