hereby remises, releases, quit claims, grants, sells, and conveys to Paul J. Locke

(hereinafter called Grantee), all her right, title, interest and claim in or to the following described real estate, situated in Shelby County, Alabama, to-wit:

A parcel of land situated in the Northwest Quarter of Section 5, Township 20 South, Range 1 East, being located in the County of Shelby in the State of Alabama and being more particularly described as follows: Commence at a point where the North line of NW 1/4 of Section 5, Township 20 South, Range 1 East, crosses centerline of Columbiana-Calera Road (County Road #438) and run South 22 deg. 46' West for a distance of 330 feet to a point; thence run South 08 deg. 30' West for a distance of 500 feet to a point; thence run South 05 deg. 56' West for a distance of 460 feet to the point of beginning of herein described parcel; from point of beginning thus obtained run East for a distance of 1404.62 feet to a point; thence run South for a distance of 150 feet to a point; thence run West for a distance of 1457.4 feet to a point; thence run Northeasterly for a distance of 155 feet to the point of beginning. LESS AND EXCEPT 20 feet of the West side for County Road #438 and 100-foot right of way for Alabama Power Company. Situated in Shelby County, Alabama.

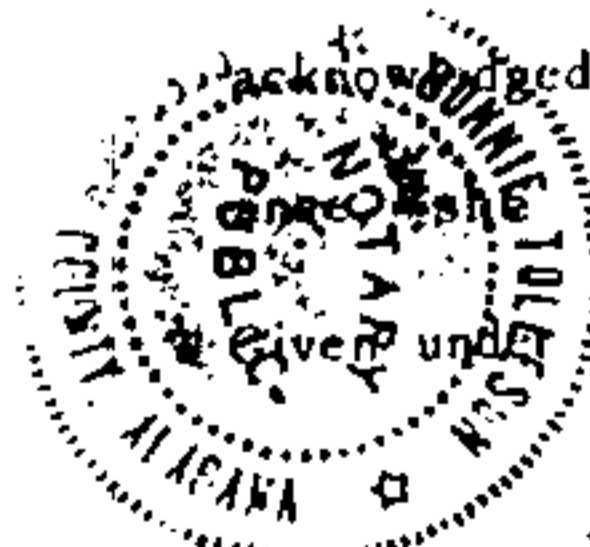
