### ARTICLES OF INCORPORATION

0F

CORRECTIONAL MANAGEMENT CONSULTING, INC.

The undersigned, acting as incorporator of a corporation under the Code of Alabama, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is CORRECTIONAL MANAGEMENT CONSULTING, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are:

- (1) to engage in consultation with correctional agencies to achieve the Constitutional operation of their facilities;
- (2) to prepare recommendations of corrective action or preventive measures for use by correctional administratorclients;
- (3) to provide any other services that will enhance the operation of client facilities;
- (4) to make contracts, guarantees, and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage, pledge of, or creation of security interest therein, not inconsistent with the provisions of the Constitution of Alabama as the same may be amended from time to time;

- (5) to purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in and with real or personal property, or other interest therein, wherever situated;
- (6) to conduct its business, carry on operations, and have offices and exercise the powers granted by the Alabama Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have the authority to issue is 1,000 shares of common stock with a par value of \$1.00 per share.

FIFTH: The mailing address of the initial registered office of the corporation is 4616 Wooddale Lane, Pelham, Alabama, 35124. The name of the initial registered agent at such address is Richard L. Grimes.

SIXTH: The number of directors constituting the initial board of directors of the corporation is three (3), and the names and mailing addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are;
