the same and that said suit is not pending in said Court.

Plaintiffs allege in said complaint that the title to said lands stands in the name of the Plaintiffs on the records in the Office of the Judge of Probate of Shelby County, Alabama, and said complaint further alleges that Plaintiffs claim title to said lands through and by virtue of a deed recorded in Deed Book 313, at Page 444 from Harry W. Dearing, Jr. and Sybil Dearing, a married man and wife, dated June 21, 1978, to Harry W. and Mary S. Dearing, that during the time of Plaintiffs ownership, they have been in actual, peaceable, adverse possession of said lands claim to own the same, and that title to said lands has stood in Plaintiffs or Plaintiffs Predecessors names on the records in the Office of the Judge of Probate of Shelby County, Alabama, for more than 23 years prior to this date.
