This Extension Agreement made this 15<sup>th</sup> day of August, 1984, between Marvin Daniel Davis, Bertram Davis and Oddie Hubbard, d/b/a Davis Brothers and Hubbard Woodyard, hereinafter called First Party and Frank R. Renn, d/b/a Renn & Company, hereinafter called Second Party and Union Camp Corporation, a Virginia corporation, hereinafter called Third Party.

WHEREAS, by corrective Timber Indenture dated May 21, 1984, First Party did grant, bargain, sell, convey and confirm unto the said Second Party all of its right, title and interest to certain trees and timber located on lands in Shelby County, Alabama, said lands and trees and timber being more particularly described in a corrective timber deed from Weaver Agency of Bessemer, Inc., dated May 21, 1984, to First Party, which is recorded in Book 355, Page 859, Office of the Judge of Probate of Shelby County, Alabama, and corrective Timber Deed from First Party to Second Party dated May 21, 1984, recorded in Book 355, Page 857, Shelby County, Alabama, reference to said Agreements being hereby made for all purposes herein, and

WHEREAS Second Party assigned all of his right, title and interest to said timber deed to Third Party by Assignment dated May 30, 1984, recorded in Book 56, Page 883, Shelby County Records, and

WHEREAS, said Agreement was for a term until November 3, 1984, and

WHEREAS, said Agreement was extended by Weaver Agency of Bessemer, Inc., until August 3, 1985, and First Party desires to grant this extension to Second Party, and Second Party desires to grant this extension to Third Party.

NOW, THEREFORE, in consideration of the sum of TEN DOLLARS (\$10.00) cash in hand paid, receipt whereof is hereby acknowledged, the First Party hereby grants to Second Party and Second Party hereby grants to Third Party an additional period until August 3, 1985, under said Timber Indenture and Third
