ARTICLES OF INCORPORATION  
OF  
ALLIED COMMUNICATIONS EQUIPMENT CORPORATION

The undersigned, acting as incorporators of a corporation under the Code of Alabama, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Allied Communications Equipment Corporation.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: To sell, install and lease communications equipment, including, but not limited to, telephone systems, two-way radios, and radio telephones; to sell, lease, service and maintain paging systems, office equipment, and other tangible personal property, including, but not limited to motor vehicles, computers, office equipment, medical equipment; all necessary and related activities thereof; and each and every other activity authorized a corporation by the Code of Alabama.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000), at One Dollars (\$1.00) par value per share. There is only one class of stock.

FIFTH: The address of the initial registered office of the corporation is 111 Highland Drive, Columbiana, Alabama 35051; the mailing address of the corporation is 111 Highland Drive, Post Office Box 916, Columbiana, Alabama 35051; the name of its initial registered agent at such address is A.
