FIRST: The name of the corporation is AMERICAN CONCRETE CONSTRUCTION CO., INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: To manufacture, transport, pour and otherwise deal with concrete and concrete products, and all necessary and related activities thereof, and each and every other activity authorized a corporation by the Code of Alabama.
