KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned property owners along an unpaved county road (referred to as "Barney Norris road") do hereby give and grant to the Shelby County Highway Department of the State of Alabama an easement, for the purpose of:

continuing periodic maintenance (blading, cherting where necessary, etc) on said road. We recognize the right of the county to maintain this road because of the many years of maintenance which the county has provided and because of its public use over the years.

said easement being more particularly described as follows, to wit:

Commence at the northwest corner of Section 15, T-21S, R-3W; thence proceed in an easterly direction for 1200 feet, more or less, to the point of intersection of the south right of way line of County Highway 26 and an unpaved road known as the "Barney Norris Road", being the point of beginning of the easement herein described; thence run in a southerly and southwesterly direction along said unpaved county road for a distance of 1500 feet, more or less. The width of said easement shall be the width of the existing roadway in place, being ditch line in cut sections and bottom of front slopes in fill sections.

For and in consideration of the benefit to our property by reason of the construction or improvement of said road, we hereby release the Shelby County Highway Department and all its employees and officers from all consequential damages, present or prospective, to our property, arising out of the construction, improvement, maintenance or repair of said road.

It is further agreed that all of the employees and officers of the Shelby County Highway Department of the State of Alabama shall have ingress and egress at any and all times to the property covered by this easement, for the purpose of:

maintenance without hindrance or delay of any kind. That the construction or improvement of the aforesaid road is a benefit to our property is hereby admitted and acknowledged.
