That in consideration of ONE HUNDRED, EIGHTY-NINE THOUSAND AND NO/100 DOLLARS (\$189,000.00) to the undersigned GRANTOR (whether one or more), in hand paid by the GRANTEE herein, the receipt whereof is acknowledged, I or we, GORDON WAYNE CARROLL, a married man, ALICE KNOWLES, one and the same person and also known as SUE KNOWLES, a married woman, TOMMY WAYNE CARROLL, a married man, RICHARD RYAN CARROLL, a married man, JAMES ROBERT CARROLL, a married man, BETTY SUE DANIEL a married woman, AND SARAH DURBIN, a married woman, (herein referred to as GRANTOR, whether one or more), grant, bargain, sell and convey unto K & S BUILDINGS, a General Partnership (herein referred to as GRANTEE, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Commence at the Southwest corner of Section 24, Township 20 South, Range 3 West; thence run East along the South line of said Section a distance of 974.97 feet, to the East right of way line of U.S. Hwy. No. 31; thence turn an angle of 106 deg. 54 min. 35 sec. to the left and run along said right of way line a distance of 873.91 feet to the point of beginning; thence continue along said right of way line a distance of 49.00 feet to Hwy.
