CORPORATION FORM WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

} KNOW ALL MEN BY THESE PRESENTS.

That in consideration of ----NINETY-ONE THOUSAND AND NO/100 DOLLARS (\$91,000.00)-----

to the undersigned grantor, DON KIRBY CONSTRUCTION, INC., a corporation,
 (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the
 said GRANTOR does by these presents, grant, bargain, sell and convey unto

JOHN W. WARD, JR., and wife, SHIRLEY S. WARD,

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor
 of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate,
 situated in Shelby County, Alabama, to-wit:

A parcel of land situated in the southwest 1/4 of the southeast 1/4 of Section 9,
 Township 21 South, Range 2 West, Huntsville Meridian, Shelby County, Alabama, and
 being more particularly described as follows: Commence at the southwest corner of
 said 1/4 1/4 section; thence in a northerly direction along and with the West line
 of said 1/4 1/4 section 520.00 feet to a point; thence with a deflection of 102 deg.
 29 min. 00 sec. right 140.38 feet to the point of beginning; thence continue along
 the projection of the previous course 336.92 feet to the centerline of an unpaved
 road; thence in a northerly direction along and with the centerline of said unpaved
 road, 332.1 feet (for the purpose of this legal description, from the last course,
 with a deflection of 85 deg. 13 min. 47 sec. left, 324.36 feet) to a point in the
 centerline of said unpaved road and on the projection of a fence line; thence along
 said fence and projection thereof, 325.00 feet to a point (for the purpose of this
 legal description, from last chord, with a deflection of 96 deg. 50 min. 18 sec.
 left 325.00 feet to a point) of said fence; thence with a deflection of 80 deg. 46
 min. 36 sec. left, 313.95 feet (deed 75 deg. 45 min. left 301.0 feet) to the point
 of beginning, forming a closing interior angle of 82 deg. 50 min. 41 sec. and being
 situated in Shelby County, Alabama. LESS AND EXCEPT the right of way for the
 unpaved road.

 GRANTEES, their heirs and assigns, that is lawfully seized in fee simple of said premises, that they are free from all encum-
 brances,

that it has a good right to sell and convey the same as aforesaid, and that it will and its successors and assigns shall, warrant
 and defend the same to the said GRANTEES, their heirs, executors and assigns forever, against the lawful claims of all persons.
