NOW THEREFORE, in consideration of the premises, said Mortgagors, Donald N. Guthrie, a married man, C. Austin Johnson, a married man, James T. Johnson, III, a married man and James T. Johnson, Jr., a married man

and all others executing this mortgage, do hereby grant, bargain, sell and convey unto the Mortgagee the following described real estate, situated in Shelby County, State of Alabama, to-wit:

Commence at the SW corner of the NW 1/4 of NE 1/4, Section 26, Township 21 South, Range 1 West; thence run North along the West line of said NW 1/4 of NE 1/4 a distance of 289.39 feet to a point on the Northern 30-foot right-of-way line of State Highway No. 70; thence turn an angle of 90 degrees 32 minutes 33 seconds to the left and run Westerly along said right-of-way line a distance of 30.33 feet to a concrete right-of-way monument on the Eastern right-of-way line of State Highway No. 25 (Columbiana By-Pass); thence turn an angle of 57 degrees 24 minutes 40 seconds to the right and run Northwesterly along the said right-of-way line a distance of 102.42 feet to a concrete right-of-way monument; thence turn an angle of 58 degrees 05 minutes 38 seconds to the right and run Northeasterly along said right-of-way line a distance of 147.24 feet to a point; thence turn an angle of 65 degrees 11 minutes 00 seconds to the right and leaving said right-of-way line run Easterly a distance of 364.14 feet to a point on the centerline of an open ditch; thence turn an angle of 127 degrees 04 minutes 23 seconds to the right and run Southwesterly along said ditch line a distance of 271.73 feet to a point on the North 30-foot right-of-way line of State Highway No. 70; thence turn an angle of 52 degrees 14 minutes 19 seconds to the right and run Westerly along said Right-of-way line a distance of 175.61 feet to the point of beginning. Said property is warranted free from all incumbrances and against any adverse claims, except as stated above.

To Have And To Hold the above granted property unto the said Mortgagee, Mortgagee's successors, heirs, and assigns forever; and for the purpose of further securing the payment of said indebtedness, the undersigned agrees to pay all taxes or assessments when imposed legally upon said premises, and should default be made in the payment of same, the said Mortgagee may at Mortgagee's option pay off the same; and to further secure said indebtedness, first above named undersigned agrees to keep the improvements on said real estate insured against loss or damage by fire, lightning and tornado for the fair and reasonable insurable value thereof, in companies satisfactory to the Mortgagee, with loss, if any, payable to said Mortgagee; as Mortgagee's interest may appear, and to promptly deliver said policies, or any renewal of said policies to said Mortgagee; and if undersigned fail to keep said property insured as above specified, or fail to deliver said insurance policies to said Mortgagee, then the said Mortgagee, or assigns, may at Mortgagee's option insure said property for said sum, for Mortgagee's own benefit, the policy if collected, to be credited on said indebtedness, less cost of collecting same; all amounts so expended by said Mortgagee for taxes, assessments or insurance, shall become a debt to said Mortgagee or assigns, additional to the debt hereby specially secured, and shall be covered by this Mortgage, and bear interest from date of payment by said Mortgagee, or assigns, and be at once due and payable.
