STATEMENT OF LIEN

That said Westburne Supply, Inc. claims a lien upon the following property situated in Shelby County, to wit:

A parcel of land situated in the SE1/4 of the NE1/4 and the NE1/4 of SE1/4 of Section 14, Township 20 South, Range 3 West, Shelby County, Alabama, more particularly described as follows:

Commence at the NE corner of the SE1/4 of the NE1/4 of Section 14 and run South along the forty line for 663.5 feet; thence turn right an angle 13° 12' and run for a distance of 137.7 feet to the point of beginning; thence run South 14° 15' East along West boundary of Lee Street for 581.45 feet to a point; thence turn an angle to the right of 85° 5' and run North 80° 40' West for 588.15 feet to a point; thence run North 47° 44' 45" East for 116.18 feet; thence North 60° 3' 34" East for 99.39 feet; thence North 38° 6' 21" East for 99.39 feet; thence North 16° 9' 8" East for 99.39 feet; thence North 5° 48' 5" West for 99.39 feet; thence North 28° 37' 27" West for 107.15 feet; thence North 32° 34' 38" East for 44.53 feet; thence South 75° 0' 27" East for 94.90 feet; thence South 85° 29' East for 222.47 feet; thence South 86° 33' East for 160.50 feet; thence South 39° 36' East for 40.37 feet to the point of beginning.

This lien is claimed separately and severally, as to both the building and improvements thereon and the said land.

That said lien is claimed to secure an indebtedness of \$5,192.37 with interest from, to-wit: the 14th day of May, 1985 for the supply of plumbing materials to Mechanical Service and Erection Corporation.
