RIDER TO MORTGAGE

_25_th This RIDER TO MORTGAGE is made this _____ , 19 85 , and is incorporated into and shall be deemed to amend and supplement that certain Mortgage (hereinafter referred to as "Mortgage") executed simultaneously herewith by the undersigned (hereinafter referred to as "Mortgagor") to secure Mortgagor's Note to COLLATERAL INVESTMENT COMPANY (hereinafter referred to as "Mortgagee") and covering the property described in the Mortgage.

In addition to the covenants and agreements made in the Mortgage, Mortgagor and Mortgagee further covenant and agree as follows:

- A. To amend Paragraphs No. 2 and 3 of said Mortgage by deleting the same in its entirety and in lieu thereof substituting the following language, to-wit:
 - Together with and in addition to the monthly payments of principal and interest payable under the terms of the note secured hereby, the Mortgagor will pay to the Mortgagee, on the first day of each month until said Note is fully paid, the following sums:
