PRO TANTO RELEASE AND SETTLEMENT AGREEMENT

This Pro Tanto Release and Settlement Agreement is made and entered into by and between CROCKER NATIONAL BANK, on behalf of itself, its divisions, subsidiaries, affiliates, successors, predecessors, assigns, and agents, hereinafter referred to as "Plaintiff", on the one hand, and RICHARD G. ANDERSON, SPANISH PRIME, INC., CENTRAL ALABAMA FOREST PRODUCTS, INC., and any and all of their employees, associates, partners, shareholders, officers and directors, or any other such persons in any way remotely connected with the above-named personal and legal entities, hereinafter referred to as "Defendants", on the other hand.

There is presently pending in the United States District Court for the Northern District of Alabama, Southern Division, a certain lawsuit styled "Crocker National Bank v. Richard G. Anderson, et al."; Civil Action No. 83-L-1269-S, hereinafter referred to as the "lawsuit".

NOW, THEREFORE, for and in consideration of the foregoing premises, the mutual promises undertaken herein and other good and valuable consideration, receipt of which is hereby acknowledged, Plaintiff and Defendants agree as follows:

1. Plaintiff hereby releases and discharges Defendants from any and all claims, damands, actions, judgments, executions, damages, causes, expenses, and compensation, in law or equity, that it ever had, or now has, or may have, known or unknown, which were asserted in or could have been asserted in or in any way related to the

lawsuit and with the purchase, sale, or conversion of a Prentice 210 Knuckleboom Loader, serial #21305, which was involved in the lawsuit. Plaintiff expressly reserves its rights to proceed against Charles W. Beam and this Pro Tanto Release and Settlement Agreement does not in any way affect whatever rights it has against Charles W. Beam.

- 2. Plaintiff hereby conveys whatever right, title, or interest it has or had in the Prentice 210 Knuckleboom Loader, serial #21305, to Defendants. Plaintiff further states that neither it, nor anyone or any entity acting on its behalf, will make any claim to said Loader.
- 3. The Defendants hereby release and discharge Plaintiff from any and all claims, demands, actions, judgments, executions, damages, causes, expenses, and compensation, in law or equity, that they ever had, or now have, or may have, known or unknown, against the Plaintiff.
- 4. This Pro Tanto Release and Settlement Agreement is a compromise of the liability of the Defendants, but it is not intended to satisfy the judgment against or in any way release or discharge the liability of Charles W. Beam.
- 5. The Plaintiff further agrees that it will move to dismiss with prejudice the lawsuit filed by it.
