RIGHT OF WAY PASEMENT

For and in consideration of One Dollar good and valuable consideration, the receipt of all of which is hereby acknow-) and other ledged, the undersigned do (does) hereby grant to South Central Bell Telephone Company, its licensees, successors, assigns, allied and associated companies, a right of way easement to construct, operate, maintain, add or remove such lines or systems of communications or related services as the grantee may require, from time to time, consisting of poles, guys, anchors, serial, buried and underground cables and wires, cable terminals, splicing boxes, pedestals, conduit, manholes, markers, and other amplifiers, boxes, appurtenances or devices upon, over and under a strip of land 20 feet wide across the following lands in Shelby County (Parish) State of Alabama described as follows: that portion of land belonging to Mental Health Board of Chillon/Shelby in the NW% of Section 11.
