AGREEMENT REGARDING REASONABLE ACCESS  
TO PROPERTY

WHEREAS, First Christian Church of Birmingham, Inc.,

WHEREAS, Estes H. and Florence Parker Hargis Charitable Foundation and Hargis Daffodil Hills Foundation own property immediately adjacent to the said Hargis Christian Retreat, and

WHEREAS, the above-referenced parties entered into a settlement agreement as part of the final settlement of the Estate of Florence Parker Hargis, which said settlement was approved by a Decree on Final Settlement of the said Estate, Probate Court, Jefferson County, Alabama, Case No. 92670, dated October 10, 1983, and

WHEREAS, said settlement agreement incorporated therein said Final Decree provided that the said Church would execute an agreement to the Foundation relating to access to the Foundation property.

NOW, THEREFORE, in accordance with the Decree on Final Settlement dated the 10th day of October, 1983, in the Estate of Florence Parker Hargis, Deceased, rendered by the Probate Court of Jefferson County, Alabama, Case No. 92670, the undersigned Church does hereby agree that the
